

Far less fortunate far worse off

Entering this financial year's final quarter, Bridge for Asylum Seekers continues its crucial support to those desperate for safety and stability in Australia. So far this year, we have distributed \$244,315 across 75 households— 125 individuals, including 30 children.

Despite our efforts, financial constraints threaten the

support we can offer. In the first month of the financial year \$38,000 was distributed but (due to increasing funding challenges) our average monthly spend is now just \$27,146. This plunge leaves many asylum seekers without

budget has provision for \$20.23 million for expenditure on payments for asylum seeker support administered by Services Australia. This is a tiny improvement over the estimated spend

of \$20.16 million in 2024-25, but a better (yet too small) improvement over 2023-24's miserly \$16.4 million. However, this small increase in spending does little to reverse

the massive cuts to support for people seeking asylum since 2015-16, with the 2025-26 allocation representing a 93% cut on 2015-16 expenditure. 2015-16

this housing situation ended.

Manu was sleeping in a friend's car when he was referred to Bridge so we immediately provided crisis support, with our rental and living allowances continuing for him until Home Affairs fixed the administrative error with his visa.

Manu was finally granted SRSS and

no longer needs our support.
