

ANNUAL REPORT 2024-25



The financial year 2024-25 remained a challenge for people seeking asylum with no or very limited means. Affordable rental accommodation continued to be scarce and increased costs of living placed many in danger of homelessness and/or malnutrition. The demand for financial assistance from Bridge for Asylum Seekers (Bridge) remained high, with demand again outstripping supply.

As always, Bridge is extremely grateful to our donors: individuals, philanthropic organisations and the NSW ClubGRANTS program*. We wish to acknowledge their generosity. It allowed us to provide a critical lifeline to those seeking asylum who had no other means of support. Without our donors this would not have been possible.

In 2024-25, Federal Government asylum seeker support (administered by Services Australia) increased slightly to an estimated expenditure of \$20.16 million**. While this amount was up from \$16.4 million in 2023-24, it represented less than 7% of the \$300 million spent in 2015-16^.

Attempting to provide a basic safety net for those in our community seeking asylum, but destitute and potentially homeless, continues to fall to Bridge and other not-for-profits and their donors.

* The ClubGRANTS scheme is a shared State Government-Club Industry program, funded by a 2.25% gaming machine tax rebate provided by the State Government to those registered clubs with gaming machine profits in excess of \$1 million per annum.

Bridge's Key Achievements 2024-2025

Providing \$306,854 [\$486,892 in 2023-24] in client support.

Supporting 89 households with living allowances and contributions to rent. These households comprised 148 clients, of whom 37 were children.

Submitting 14 grant applications and completing seven acquittals

Receiving ten grants, some of which had been applied for in the previous financial year

Maintaining low operational costs of \$1,874 (0.61% of total outgoings) thus ensuring direct client support represented 99.39% of expenditure

Raising a total grant /donation income of \$309,023 [\$330,566 in 2023-24[†]] comprising:

Numbers of clients assisted with living allowances/rent support

In 2024-25, \$306,854 was spent on client support, specifically living allowances and/or rent assistance for 148 people seeking asylum including 37 children, in 89 households.

Distribution of Bridge funds

The focus for Bridge in 2024-25 was on those asylum seekers with no work rights or unable to work due to trauma (either physical or psychological), ill health, child care needs or a lack of language. With no Federal Government assistance available for any of Bridge’s clients, our allowances were essential to prevent people becoming destitute and consequently homeless.

Where do our clients come from?

In 2024-25 our clients came from 31 countries: Afghanistan, Algeria, Bangladesh, Botswana, Brazil, Burundi, Cameroon, Democratic Republic of the Congo, Fiji, Guinea, India, Indonesia, Iran, Iraq, Kenya, Kuwait, Lebanon, Malaysia, Mongolia, Myanmar, Namibia, Nigeria, Pakistan, Palestine (State of), Papua New Guinea, Sierra Leone, Somalia, Sri Lanka, Tanzania (United Republic of), United Arab Emirates and Zimbabwe.



Committee members
